## 4. Committee Updates

- Business Engagement John Danko and Willy Moore
  - Provided an update on the September meeting including a presentation on apprenticeship from MD Labor
- Operations Yariela Kerr-Donovan
  - o Announced that this committee as coming back as the Career Centers are fully open
  - There was a request for new members
- Strategic Alliance Yariela Kerr-Donovan
  - Strategic Alliance will be reintegrated and the focus will no longer be on policy
  - The Board members are so diversified and the boards and groups they belong to, that Strategic Alliance will work to connect the works of the various boards and groups or members belong
  - o Will discuss further as the 2019 material need be refreshed and updated
  - o There was a request for new members as well as a Chair and Co-Chair
- Youth Rachel Pfiefer and Sara Muempfer
  - O Work is continuing to work on their 6-12-24 month action plan
  - The focus is on leadership; Voice of Youth; and Youth as Experts
  - Working on increasing youth jobs and wraparound services
  - Baltimore Promise youth are working with the Youth Committee and are being compensated
  - Youth will meet again November 11 and the action plans should be completed by that meeting
- Workforce System Effectiveness Nancy Jordan Howard and Melanie Styles
  - o WSEC will take the oversight of WIDS on an interim basis
  - MOED anticipates taking WIDS at the end of the year
  - WSEC met on September 10 and will meet again September 20
  - There was a request for additional members
- MOED Updates Jason Perkins-Cohen and Yariela Kerr-Donovan
  - Centers are fully open without appointments

- It was asked for that MOED provide Center traffic numbers since fully reopening

   Jason Perkins-Cohen stated that these numbers will be provided at the next
   Board meeting
- YouthWorks ended in August and served almost 6,400 youth
- o 2020 YouthWorks participation as 25% higher than last year's YouthWorks
  - 6,371 youth completed a Youth Works application
  - Everyone that completed the YouthWorks application was offered employment
  - 5,200 actually worked
- Youth Department held the following web based projects:
  - Money Mondays Financial Literacy
  - Wisdom Wednesdays Various Topics
  - Bright Future Fridays College and Career Readiness
- It was asked is MOED plans to expand YouthWorks to a year-long program. MOED and BCPS is partnering on a work based learning program

## Health Corps

- MOED is working with the Health Department and other partners with 300 transitional jobs
- o This project is anticipated to continue through the end of the year

# • StoryTelling Campaign

- Yariela Kerr-Donovan explained the StoryTelling Campaign and asked Board members to record a video and their story

- o MOED has hired a consultant, Nancy Murphy, that is helping with this project
